**ORDER:**

In the reference 1<sup>st</sup> read above, Government issued orders to undertake development of Mass Rapid Transit System (MRTS) project on design, build, finance, operate and transfer (DBFOT) basis in Public Private Partnership (PPP) mode through pre-qualification of Bidders (Global Tenders), duly following the latest RFQ guidelines of Ministry of Finance (MoF), Government of India (GoI).

2. In the reference 2<sup>nd</sup> read above, Government have authorized the Managing Director, Hyderabad Metro Rail Limited to short list the eight applicants as pre-qualified Bidders for issue of Request for Proposal (RFP) and other bid documents for submission of Financial Bids for development of the Project on DBFOT basis.

3. In the reference 3<sup>rd</sup> read above, Government have constituted a Committee to receive, open and evaluate the Request for Proposal (RFP) bids as per procedure with Secretary to Government (R&E), Finance Department; Managing Director, Hyderabad Metro Water Supply and Sewerage Board; and Managing Director, Hyderabad Metro Rail Limited. The Committee shall receive and open the Financial Bids for the Project and carry out the evaluation of the same with the help of Evaluation Consultant, M/s. Fortress Infrastructure Advisory Services; Technical Consultant, M/s. Balaji Rail Road Systems Limited; Financial Consultant, M/s. Deloitte Touche Tohmatsu India (P) Limited and the Legal Consultant, M/s. Luthra & Luthra and shall submit recommendations to the Government for consideration of the Financial Bids through the Chairman, HMRL.

4. The Managing Director, HMRL has reported vide reference 4<sup>th</sup> cited that the Committee received and opened the Financial Bids on the Bid Due Date, July 14, 2010. Out of the six Pre-qualified consortia / companies who have purchased RFP documents the following three consortia / companies have submitted the Financial Bids.

5. The Committee constituted in the reference 3<sup>rd</sup> read above has recommended that the lowest Bidder M/s. Larsen & Toubro Limited, who have sought the lowest Grant of Rs.1,458 crore (Rupees One thousand four hundred and fifty eight crore only) be declared as the Selected Bidder and submitted recommendations to the Government through Chairman, HMRL.

6. Government have examined the above proposal in detail and after careful examination decided to approve the selection of the lowest bidder viz., Larsen & Toubro Limited as the Concessionaire to develop the Hyderabad Metro Rail Project at their quoted grant amount of Rs.1,458 crore (Rupees one thousand four hundred and fifty eight crore only) and to award the project to M/s. Larsen & Toubro Limited.

7. The Managing Director, Hyderabad Metro Rail Limited shall take necessary further action in the matter.

8. This order issues with the concurrence of Finance Department vide their U.O.No.8410/267/A1/Expr.M&F/2010, dated 2.8.2010.
